- ❖ All judging will be indoors.
- ❖ Move-ups will be allowed for both the Obedience and Rally trials. The request for a move-up must be in writing and presented to the trial secretary at least 30 minutes prior to the start of the trial.
- ❖ All Obedience and Rally classes will be run in jump-height order from Tall-Small. Please include your jump height(s) on the entry form.
- ❖ Crating space is limited. Unentered dogs may be asked to leave. All dogs present must be on leash or confined to their crates except when being judged.
- ❖ Food is not available at show site, but fast food is available within 2 miles.
- ❖ Training mirrors will be covered during the trial.
- ❖ Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Show Committee deems the exhibitor to be in violation of this requirement.
